## TONY WAITE ORGANISATION 2025 ANNUAL REPORT

<b>Vision</b>	Healthy community that can support each other in issues of HIV and AIDS, other chronic conditions, pandemics, and development related issues.
<b>Mission</b>	To capacitate communities to be able to participate in HIV and AIDS prevention, treatment, care and support professionally in order to have a knowledgeable community

### ORGANISATION BACKGROUND

Tony Waite Organization (TWO) is a private voluntary organisation (PVO 45/11) operating in Kariba urban, peri-urban, rural and hard to reach areas (fishing camps) where communities are separated from service providers due to the large waters of Lake Kariba. It started as a foundation in 1993 following the death of Tony Waite, a Kariba resident who worked for the Zambezi River Authority. He went public about his HIV status in 1991 on World AIDS day. He grew up as an orphan and died without a family in January 1992. He left a will for orphans and vulnerable children to benefit. The organisation, however, employed staff members through NAP I for OVC 2007. It has since began employing more and has students' attaché as the demand and services are increasing in the community.

### INTRODUCTION

Tony Waite Organisation has 5 distinctive thematic areas which are Orphans and Vulnerable Children [(OVC) supporting them through education and psychosocial support, Youths (Empowerment and emancipation as well as Sexual Reproductive Health Rights programs), Women's Health and Newborn, Sustainable Livelihoods [targeting the most vulnerable groups in the community (women, young women, youths and persons with disabilities) Palliative care and community adherence support (for people living with life limiting conditions and the elderly) as well as Psychosocial Support Services.

Several stakeholders continue to support the organisation in terms of networking and program coordination, implementation, monitoring and evaluation. The key stakeholders who worked with the organisation were District Social Development, National AIDS Council,

MOH&CC, MoPSE, Municipality of Kariba, District Development Coordinator, Nyaminyami Rural District Council, NAC, ZRP and WCoZ.

The organisation through trained community carers, key stakeholders, line ministries and local community continued identify Orphans and Vulnerable Children in need of care and support including those who need birth certificates, legal support, scholastic, economic strengthening and food assistance as part of child protection issues. Tony Waite Organisation also works with women and adolescent girls, People living with HIV and AIDS

and other life limiting conditions and has also continued supporting them through adherence and psychosocial support.

## **2. TO IMPROVE HOUSEHOLD INCOME, FOOD SECURITY AND HEALTH**

Tony Waite Organisation has continued supporting a total of 435 (220M 215F) with sustainable livelihood projects. The organisation aims to leave no one and no place behind. The mantra promotes prosperity, inclusion and resilience for every Zimbabwean. TWO has managed to align its community development programs with the National Development Strategy 1's (NDS 1), on **food security and climate resilience, job creation, youth and women empowerment**. The organisation is supporting youths and women through livelihood projects and small businesses to archive the objectives of the projects the organisation introduced some capacity building trainings, mentorship monitoring and evaluation of the projects to enhance project outputs. The main objectives of the Economic Strengthening Projects are to

- **create an enabling environment for women to become active participants in development**
- **To reduce dependency by women.**

- To enhance their income and family nutrition through their meaningful engagement in development.

### **Boer Goat Rearing**

In line with the NDS 1 on job creation, youths and women empowerment the organisation s supporting women, youths and persons with disabilities from Nyaminyami Rural District of Kariba through small livestock production (goat projects). The projects were a response to grievances shared by the beneficiaries during community engagements during Elnino induced drought and COVID-19 community awareness outreaches. Women were left with the dexterity of looking after children alone while their husbands had resorted to Sanyati and Ume alluvial gold mining and many of them stayed longer than expected without sending support to their families, hence women became overburdened with unpaid family care work. As a result the organisation supported the beneficiaries with mashona breed goats and later introduced the Boer which has genetic advantages of big frame, high quality and quantity meat. Although the project took long to realise the genetic variations in 2025 both groups Tariro Hupenyu Disability Group in Chidyamugwamu and Rutendo in Siakobvu had boer kids in their heard. The introduction of the boer breed and subsequent trainings in goat rearing projects motivated the project beneficiaries and helped in project effectiveness. The bucks were managed successfully until they adapted well to the environment. The bucks are yet to be transferred to other groups and plans are in motion as the bucks are supposed to rotate all the 4 goat rearing projects and the organisation will facilitate skills transfer through the trained members of Tariro Hupenyu Disability Group and Tatenda groups. In an attempt to enhance project effectiveness the organisation linked the groups to AGRITEX Officers in the respective communities for monitoring and supervision support. Below are the pictures of the bucks and their kids for the 2 groups which benefited from the boer breed introduction.



### **Nutritional support**

**2196 (1096M 1100F) received food support in 2025. Among the beneficiaries were 1529 (807M 722F) children, 8 (5M 3F) on ART, 2 (1M 1F) on TB treatment and 4 (2M 2F) on infant feeding program.**

The period has seen the organisation getting support from different stakeholders and partners towards nutritional support for vulnerable members of the community. Harare Athletics Club supported through an assortment of food items and the organisation's the Kapenta linkage project. The goal of the program is to enhance access to basic food commodities for the most vulnerable households in the community and people on adherence support so as to promote adherence and treatment successes. In line with

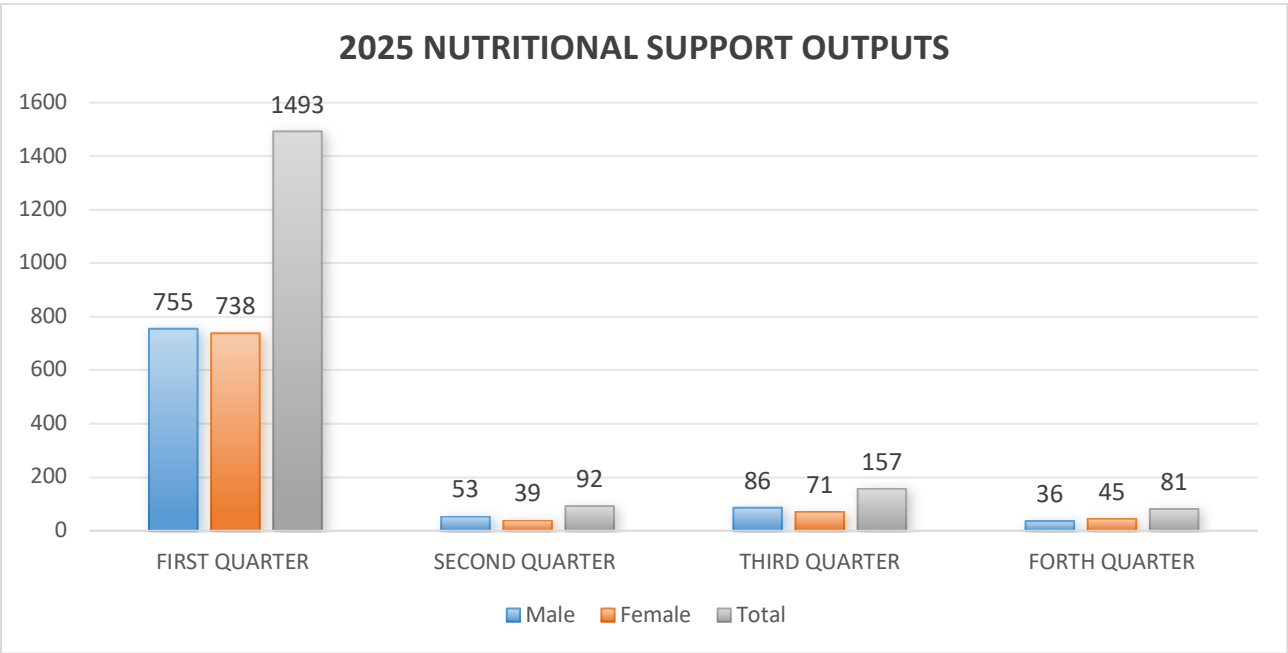
promoting treatment success the organisation recognised the World TB Day through supporting TB patients with food items.



Graph Interpretation

The graph shows the nutritional support outputs for 2025. The period January-March recorded the highest number **1493 (755M 738F)** of people supported. The surge was caused by the school feeding program which benefited **1120 (589M 531F)** children from Kadziro Primary, Tiger Primary and secondary, Msampakaruma High School learners with disability boarding house as well as others who benefited through the Lake Harvest fish heads donations and benefited **373(166M 207F)**. The 2<sup>nd</sup> quarter saw 92 (53M 39F) benefiting from the kapenta distribution. 238 beneficiaries (122M and 116F) benefited from Harare Athletics Club after marathon donation to the organisation.

NUTRITIONAL GARDENS

The organisation is supporting a total of 4 nutritional gardens benefiting a total of 184 (54F 130F) namely Padare garden in Mahombekombe, ZIHOFE garden in ward 2 Kariba urban and Charara Garden for People living with HIV as well as Charara primary school for OVC at the learning institution. The goal of nutritional gardens is to enhance nutrition and income at the event there is surplus for sale. Farming at Padare and ZIHOPFE nutritional gardens

continued and throughout members were selling green vegetables (covo), okra (derere), green mealies and herbs as well as mufushwa (dried vegetables) to both the local community and local resort Caribbea Bay, Tamarind Lodges, Waterfront and Kariba Chillspot among others. During a monitoring and support visit at the nutritional garden the Programmes Officer reinforced a shift from subsistence farming (farming for family consumption) to intensive farming (farming for business) through turning the garden introduction of a business hub. This will help the members to cater for both garden rates and household rates at the same time accessing fresh nutritious vegetables. The organisation will continue with market linkages and sustainable agricultural approaches training through engaging various stakeholders to tap from the ever-evolving agricultural revolution. Members of ZIHOPFE garden have managed to reconnect water and installed solar powered electricity which is cost effective. Members of Padare garden are continuing with their monthly contributions towards buying food items for each other.



Charara garden has had some disturbances due to members leaving employment abruptly as there is now a new management coming in and did not need all the old farm workers. The organisation is still to assist in the formation and training of new garden members when the movement is over.

#### **4) MEDICAL SUPPORT**

Tony Waite organisation through its trained community carers is implementing the SRHR program which encompasses the adherence support program (palliative care) and community meetings. A total of 1350 (350M 1000F) was reached with SRHR information during the year. The main objective of the SRHR programme is demand generation and creating referral pathways so as to improve access to health related services for children, adolescent boys and girls as well as women of childbearing age and their partners. From the total reached a total of 250 (40M 110F) were referred for HIV testing and counseling. A total of 200 couples were sensitised in the EMTCT education by community carers. EMTCT programme aims to increase male involvement in women health and the new born as their involvement is lacking. A total of 50 (15M 35F) were assisted in Gender Based Violence-related issues. The main causes of GBV among others are Spousal abuse (emotional and physical) stemming from infidelity. Most cases were assisted through counseling By Community Carers. The organisation is working hand in glove with the Department of Social Development, Ministry of Women Affairs Small and Medium Enterprises Development as well as Victim Friendly Unit to facilitate referrals and demand creation for GBV services.

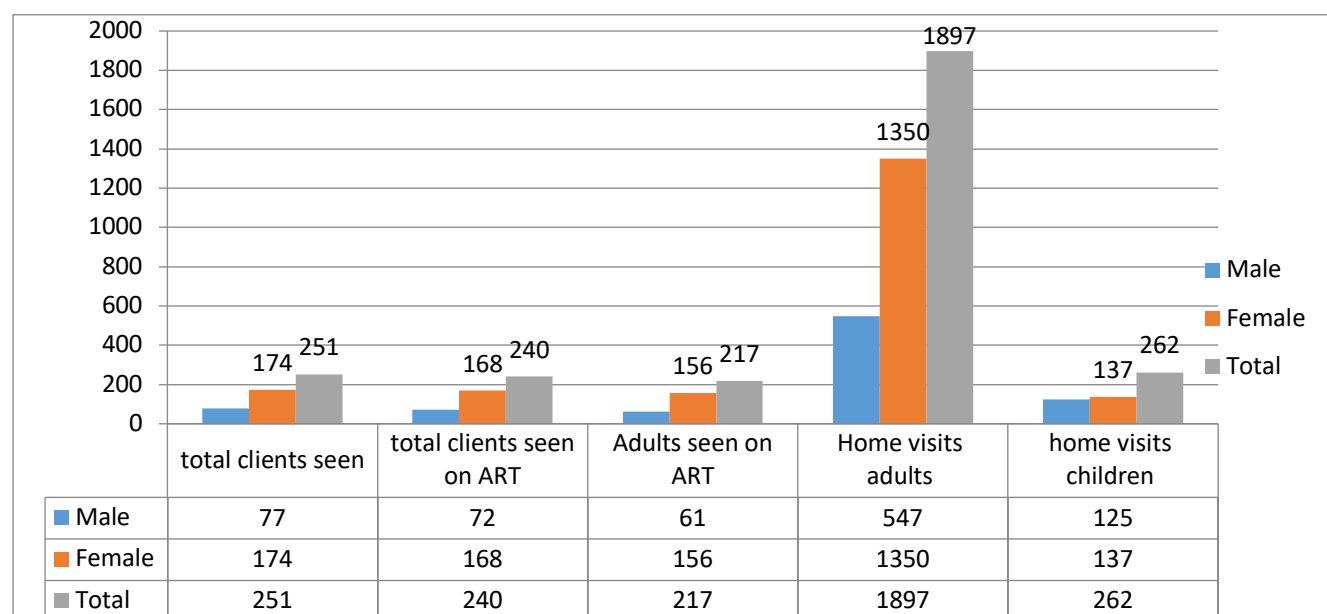

The graph above shows total number of clients seen during the year and their health conditions. Tony Waite Organisation under the adherence and palliative program works with people with various health conditions including those living with non-communicable diseases like cancer, Diabetes, hypertension as well as those living with TB & HIV. The idea of the program is to strengthen community adherence support as well as building strong support networks among peer groups for psychosocial support services. Community carers are responsible for technical support through basic patient care to primary care givers so as to improve the quality of life of patients under the Community Home Based Care.

## **Tayeyegwa HIV TB Integration Project**

### **Overview**

The goal of HIV and TB integration is to reduce TB-related deaths by 2030. According to National TB Strategic Document 2021-2025 the TB epidemic has been largely driven by HIV, with more than two-thirds of TB patients (72% in 2015) co-infected with HIV. Significant progress has been made through TB-HIV collaborative efforts. Notably, HIV testing among TB patients is approaching universal access, with 96% of TB patients having a known HIV status, and 72% of those co-infected on ART as of 2015 [National Tuberculosis Program – Strategic Plan (2017–2020)]. Despite these achievements, Kariba District continues to face specific challenges in implementing the TB program these include ***delayed contact investigations due to inadequate resources, limited resources for Early Health Detection (EHD), and low TB notification coverage***. Furthermore, as identified by the Zimbabwe National AIDS Strategic Plan (ZNASP V), there remains a significant information gap within communities regarding TB prevention and management. To address these challenges, the organisation, through the Tayeyegwa Project seeks to sensitise key stakeholders, train community carers, and conduct community outreach activities to achieve the project's overall goal of reducing infections and deaths by 2030: The key objectives of the project include:

- To increase access to TB services through strengthening community awareness and knowledge sharing on TB and HIV co-infection through sensitisation meetings, health education campaigns, and information dissemination
- Reducing TB related deaths through early identification and adherence support.
- To improve coordination and collaboration between the organisation, Ministry of Health and Child Care, and other stakeholders for an integrated and efficient TB-HIV response.



- To reduce stigma and discrimination associated with TB and HIV through community dialogues and advocacy initiatives

### Expected Outcomes

- Educated and knowledgeable community with Increased awareness and understanding of TB and HIV, resulting in improved health-seeking behaviour.
- Improved capacity of community carers and local health structures to effectively support TB and HIV prevention, detection, and management.
- Strengthened multi-sectoral collaboration and information sharing among stakeholders in Kariba Districtt resulting in enhanced contact tracing and early diagnosis, leading to timely initiation of treatment and reduced community transmission.
- Improved adherence and retention rates among clients on TB and ART treatment resulting in reduced TB-related morbidity and mortality.
- A more supportive and stigma-free community environment for people affected by TB and HIV.

The organisation has managed to hold the Stakeholder inception and Community Carer training and community outreaches. Below are the pictures during stakeholder inception and community carer training held at the DDC's Office and TWO Offices respectively

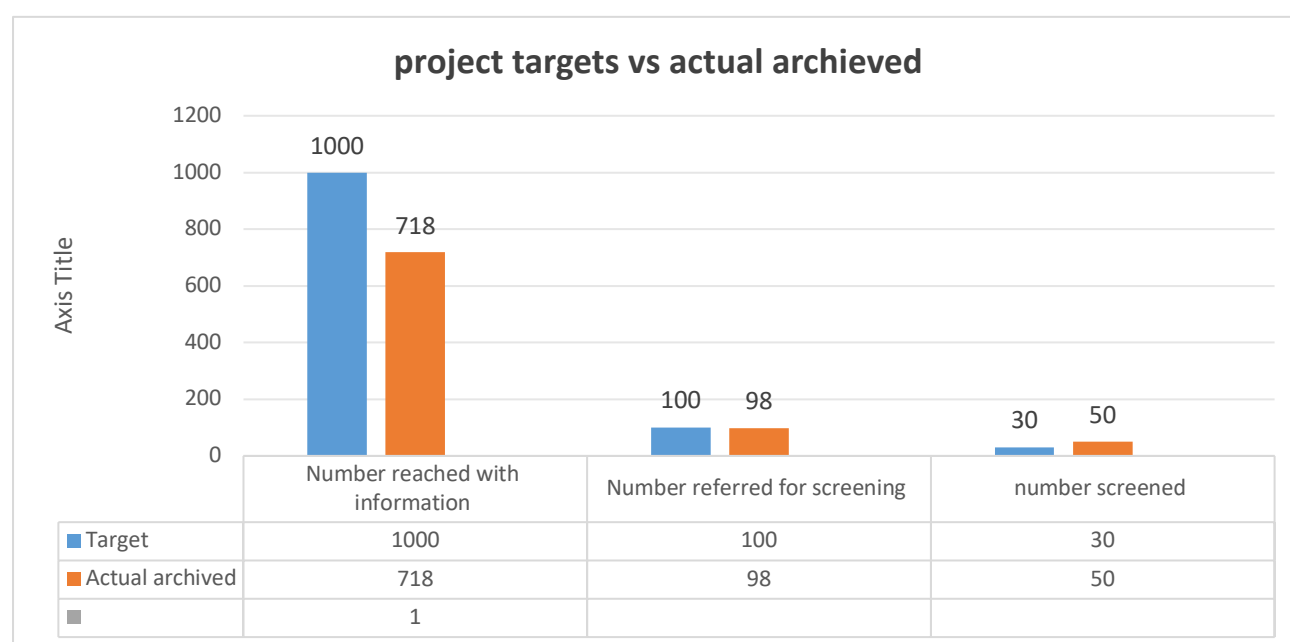
### **Key findings from the community outreaches**

#### Targets vs outputs



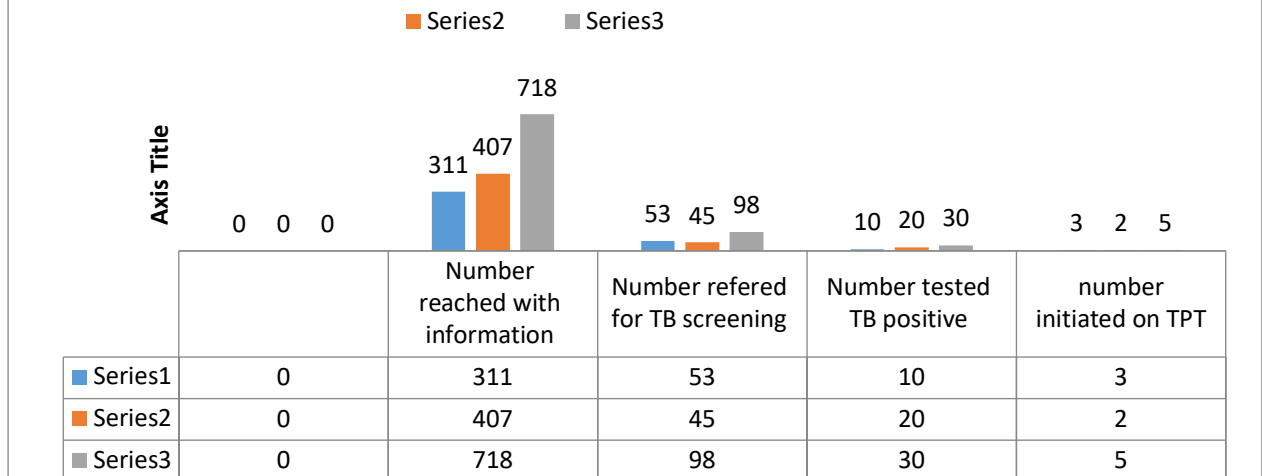
*The graph above shows the project targets vs actual archived. The project faced challenges in achieving the set targets due to delays in work plan approval and funds disbursements towards planned activities. The delays affected commencement of the project with more than 4 months as implementation was scheduled for May 2025. Number of people referred for TB screening was 98 vs a target of 100 and there was still another quarter hence TARGET was going to be achieved and 30 got screened. Other clients were not screened as they had no signs and symptoms of TB though eligible but could not be prioritised for screening as resources are scarce.*

#### Project outputs

*The graph above shows the project outputs since its launch. 718 (311M 407F) have been reached through community awareness information on TB and HIV integration. Out of these, 32 clients (15 males and 17 females) were referred for TB screening at local health facilities. Among those referred, 3 clients (1 male and 2 females) tested positive for TB, while 4 clients (3 males and 1 female) were initiated on TPT just in one month of implementation. This situation highlights the impact of undiagnosed TB cases within the community, which continue to fuel transmission and increase the disease burden. The Tayeyegwa Project will play a critical role in addressing this gap by promoting early detection, timely referral, and effective community awareness to help stop the spread of TB.*

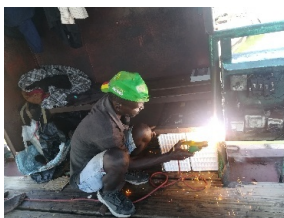
## TAYEYEGWA PROJECT JULY-DEC 2025 OUTPUTS



### KAPENTA LINKAGE PROJECT

To reduce production costs, the organisation has installed solar power on its 4 fishing rigs which has seen diesel costs reduced to over 50%. However, significant production boost has only been experienced during 4 months of winter and the rest is characterised by bad weather and very poor catches. In as much as solarisation has reduced costs production remains a challenge due to climate change affecting catches.

### ADOLESCENT SEXUAL REPRODUCTIVE HEALTH AND RIGHTS (SRHR)

#### TOSE PAMWE PROJECT

Through the Tose Pamwe Project the organisation is employing the whole organisation approach through inclusion of key stakeholders like Community Adolescent Treatment Supporters (CATS) from Zvandiri, NAC, VFU as well as Ministry of Health and Child Care. *The project's objectives is to stop child marriages & Drug and substance abuse, facilitate reporting of Gender Based Violence and to promote inclusion and support of men and boys in menstrual hygiene and creating demand for SRHR services among adolescent girls and boys. A total of 800 (350M 450F) among them were 14 (4M 10F Youths Out of school (YOS). Topics discussed are self-awareness and drug and substance abuse, menstrual hygiene, communication, decisions and decision making, friendships & peer pressure.*

### Issues identified during the sessions

- ✓ Adolescents are engaging in casual sex because of various reasons these include effects of pornography, sex for entertainment, transactional sex
- ✓ Drug use and abuse is also common among adolescents as some want to experiment euphoria and ecstasy associated with drug use.
- ✓ In as much as there are various programs towards safeguarding girl child from child marriages and Gender Based Violence child marriages remains a challenge in Kariba District. In some prosecute cases, the girl child often defends the perpetrator due to financial benefits and conspiracy.
- ✓ YOS prefer programs which has benefits especially seating allowances although they show very limited will in taking innovative projects which generates income for them.

### SCHOLASTIC SUPPORT AND PSYCHOSOCIAL SUPPORT

Support was given to 50(23 m27f) with 26 (12M 14F) who got their fees paid.

The organisation supported Nyanyana and Tiger Skills 86 female learners with clothes. 6 sewing machines were distributed to Mahombekombe secondary for use by 88(23m 65f) learners for 2025. The donation will see the school training both male and female learners in reusable sanitary wear pads making. **Psychosocial support**- addresses emotional, social, mental, and spiritual needs, building internal and external resources for individuals, families, and communities to cope with adversity and promote well-being. The program encompasses actions that address the psychological and social needs of individuals, families, and communities. It aims to promote

well-being and resilience in the face of challenging circumstances. The organisation's objective for PSS includes helping vulnerable members of the community to Cope with adversity, crisis, trauma, and other stressful events. Building resilience through strengthening both individuals' and communities' capacity to withstand and recover from difficult situations. Promoting well-being through offering psychosocial support aims to enhance emotional, social, mental, and spiritual well-being as well as Facilitating recovery through supporting individuals and families in recovering after a crisis has disrupted their lives and helps them return to normality. Therefore, to realise the objectives of the program the organisation works with Persons with Disabilities, OVC, Women, Girls, Young Women and Youths. kout competition where 2 scooped first and second prices and support has continued to the provincial level. ## WINTER SCHOOL FOR SRHR, LAW, MENTAL HEALTH, DRUG POLICY REFORM AND HARM REDUCTION

### Objectives

The Programmes Officer and 2 other adolescent boys applied and were selected to participate in the Zimbabwe Civil Liberties and Drug Network & Women Health Issues Trust Zimbabwe Winter School for SRHR, Law, Mental Health and Drug Policy Reform. The training had 6 distinct objectives these are:

- *building knowledge*
- *advancing practical approaches to advocate for drug policy reforms*
- *raising awareness in the intersectionality of SRHR Mental Health and Drug use*
- *developing ways of combating HIV & other infections among people who use and inject drugs*
- *promoting advocacy*
- *challenging stigma and discrimination among women and youths who uses drugs.*

### The 5 expected outcomes of the training were:

- a) *knowledge acquisition through evidence-based approaches, best practices and innovative interventions while also developing practical skills such as SRHR as a*



*human rights framework policy, mental health from human rights lens, advocacy techniques as well as program planning and evaluation.*

- b) Equipping participants with skills and tools for evidence based SRHR and drug policies*
- c) Creating connections and collaborations among likeminded individuals and organisations which will facilitate knowledge osmosis, support and collaboration.*
- d) Participants able to advocate for policy reforms through innovation*
- e) Challenging and reducing stigma and discrimination associated with marginalised communities like people who use drugs, sex workers and individuals in accessing SRHR services*

#### **Key outcomes from the winter school.**

- *It provided a conducive environment for networking with other like-minded organisations in SRHR, HIV & AIDS, Gender, Mental Health and Drug Policy Reforms and rehabilitation programming- this will help is possibilities of formulating consortiums with other like-minded organisations like Zimbabwe Civil Liberties and Drug Network and others.*
- *Drafting of a cost-effective model responding to mental health issues among the adolescent girls and boys in secondary schools*
- *Gaining practical and effective ways of responding to mental health issues stemming from drug use using locally available resources.*
- *Ways to address stigma and discrimination among women and girls using drugs.*

#### **COORDINATION**

Tony Waite Organisation (TWO) applies a multi-stakeholder approach across programme design, implementation, monitoring, evaluation, and learning (MEL). During the reporting period, the organisation actively engaged in key coordination and stakeholder platforms to strengthen programme alignment, accountability, and impact. TWO participated in District AIDS Action Committee (DAAC) and Provincial AIDS Committee (PAC), ZAN chapter meetings, which are central to coordinating a multi-sectoral response to HIV and AIDS. The organisation also engaged in Women's Coalition of Zimbabwe (WCoZ) coordination meetings to support harmonised programming for women and girls. At district level, TWO participated in Drought Relief, Child Protection, and Kariba Gender Stakeholder meetings,

contributing to coordinated responses aimed at building resilient communities and preventing child abuse and gender-based violence. In the livelihoods sector, TWO remained an active member of the Zimbabwe Kapenta Producers Association and a joint Zimbabwe and Zambia committee (PROFISHBLU), attending planning and feedback meetings that support sustainable kapenta fishing on Lake Kariba.

In addition, TWO is a member of the District Nutrition Committee, which is responsible for assessing food insecurity, identifying and registering vulnerable households, and coordinating food assistance interventions among partners. Through this platform, the organisation contributed to targeting, referral, and monitoring of food distribution programmes.

Overall, TWO coordinated with local, district, provincial, and national stakeholders to ensure programme coherence, avoid duplication, and enhance collective impact. The organisation also participated in official events and initiatives led by government authorities and partners, reinforcing collaboration, shared ownership, and a unified approach to development and humanitarian programming. **Below are some of the pictures of activities attended during the year.**
